THE CITY OF EDINBURGH COUNCIL (CRAIGLOCKHART/SLATEFORD AREA)  
(TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 –  
TEMP/24/189

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Craiglockhart/Slateford Area) (Temporary Road Restriction and Traffic Regulation) Order 2024”. The order shall have effect on the Twenty-first day of October Two thousand and twenty-four and shall remain in force up to and including the Thirty-first day of March Two thousand and twenty-five.
2. In this Order the following phrases have the meanings respectively assigned to them:  
“Article” means an Article of this Order;  
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;  
“motor vehicle” has the same meaning as in Section 136 of the 1984 Act;  
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;  
“the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and  
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate a safe working area for SGN mains replacement works (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit to be driven any motor vehicle on **Craiglockhart Avenue**, from the extended south-eastern kerbline of Lanark Road/Slateford Road, south-eastwards to the extended north-western kerbline of Colinton Road, otherwise than in a *south-eastbound* direction;
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on: (1) *both sides* of: (i) **Lanark Road**, from the extended north-eastern kerbline of Inglis Green Road, north-eastwards to the extended southern kerbline of Craiglockhart Avenue; (ii) **Slateford Road**, from the extended southern kerbline of Allan Park Road, south-westwards to the extended northern kerbline of Craiglockhart Avenue; (iii) **Craiglockhart Avenue**, from the extended south-eastern kerbline of Lanark Road/Slateford Road, south-eastwards to the extended north-western kerbline of Colinton Road; and (iv) **Glenlockhart Road**, from the extended south-eastern kerbline of Colinton Road, south-eastwards for a distance of 75 metres or thereby; and (2) *east/north-east side* of **Colinton Road**, from the extended northern kerbline of Craiglockhart Park, generally northwards to the extended north-eastern kerbline of Craiglockhart Road North; and
  - (c) drive or cause or permit to be driven any vehicle on the road specified in column 1 so as to make the prohibited turn specified in column 2, into the road specified in column 3 of Schedule 1 hereto.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.

6. 'The City of Edinburgh Council (Greenways) Order 1997', as amended, will be suspended in so far as the *no stopping restrictions* on the specified sections of **Lanark Road** and **Slateford Road** are affected by this Order.
7. The alternative route for through vehicular traffic will be by way of Colinton Road, Polwarth Terrace, Ashley Terrace, Shandon Place and Slateford Road.
