

Events in West Princes Street Gardens – conditions and working parameters

Key principles:

West Princes Street Gardens and the Ross Bandstand are historic and iconic sites within Edinburgh's City Centre and World Heritage Site with the gardens forming part of Edinburgh's designated Garden and Designed Landscape of the New Town Gardens. The Gardens contain a series of listed monuments and structures such as the Ross Fountain and is of archaeological significance overlying the remains of the Nor Loch and bounded by the A-listed St Cuthbert's Church & Graveyard. The southern part of the park is formed by Edinburgh Castlehill containing the Castle's Well House (a Scheduled Ancient Monument) and which is also a (Site of Special Scientific Interest) SSSI. It is primarily used as a park for the public to enjoy and this should be taken into consideration when preparing event proposals, ie. access to the park for the general public should be maximised and the potential for damage to the gardens should be mitigated.

General conditions of use:

- A reinstatement bond (determined by both Parks & Greenspaces and Bereavement Services - See St Cuthberts T&C's) will be payable 4 weeks before the commencement of an on-site build. Access onto the site will not be granted until the bond payment is received;
- A rental fee will be set by Parks & Greenspaces determined by the scale and impact of the event
- As part of the application process to use the park, you will be required to provide details of the proposed event, produce a risk assessment and provide proof of public liability insurance;
- A Vehicle Access Plan and separate Tree & Root Protection Plan requires to be submitted as part of your application for approval of Council officers.
- Depending on the scale and/or complexity of the event, it may be determined that an on-site presence is required by CEC to ensure compliance with the conditions of use. This will be confirmed by a Council officer once your application has been reviewed and any associated costs will be the responsibility of the applicant/operator.
- A multi-agency Event Planning and Operations Group (EPOG) meeting may be required to ensure the safe delivery of your event. If so, you will be expected to produce an Event Safety Management Plan (ESMP) and present your proposals to the group for their comment and approval. We would recommend that you review best practice guidance, e.g. [The Purple Guide](#), on what to include within your ESMP.
- As part of the process you may also require to gain permission from other departments of the Council, such as Licensing, Environmental Health, Roads Events (for temporary traffic regulation orders), Bereavement Services, Archaeology, Planning and Public Safety. All departments of the council must confirm that they are content with the plans for the event before it can take place.

***Access through St Cuthbert's Church & Graveyard – conditions of use -**

- Access for public must be maintained during normal Garden opening times.
- Closure of access will only be allowed outwith normal opening times (variable, seasonal changes applicable).
- Access for St Cuthbert's Church parishioner's and CEC Bereavement Services has priority – coordination with the church and Bereavement Services is essential to clarify timings of services or other requirements. There should be no parking in the graveyard under any circumstances.
- Access for CEC Bereavement Services to the kirkyard must be maintained to ensure required work is carried out – coordination with the Bereavement Services is required.
- Vehicle size will be limited to 3.5t vehicles for access through St Cuthbert's churchyard. Dispensation can be granted for limited use of vehicles up to 7.5t for major events. Please submit a detailed vehicle access plan detailing the frequency and reasoning for vehicles over and above the 3.5t limit for assessment by Council officers.
- Banksman must always be used while vehicles move through the churchyard.
- Provide a method statement for the protection of tombs and gravestones along the complete length of the pathway through St Cuthbert's Church and Graveyard.
- The repair of any damage caused to the graveyard, it's monuments or landscape as a result of the event with costs met in full by the applicant/event organiser.
- Limitation on heights will be required for the protection of tree canopies along the route of the path. This should be detailed in the required Event Management Plan which will include a Vehicle Access Plan and Tree & Root Protection Plans.

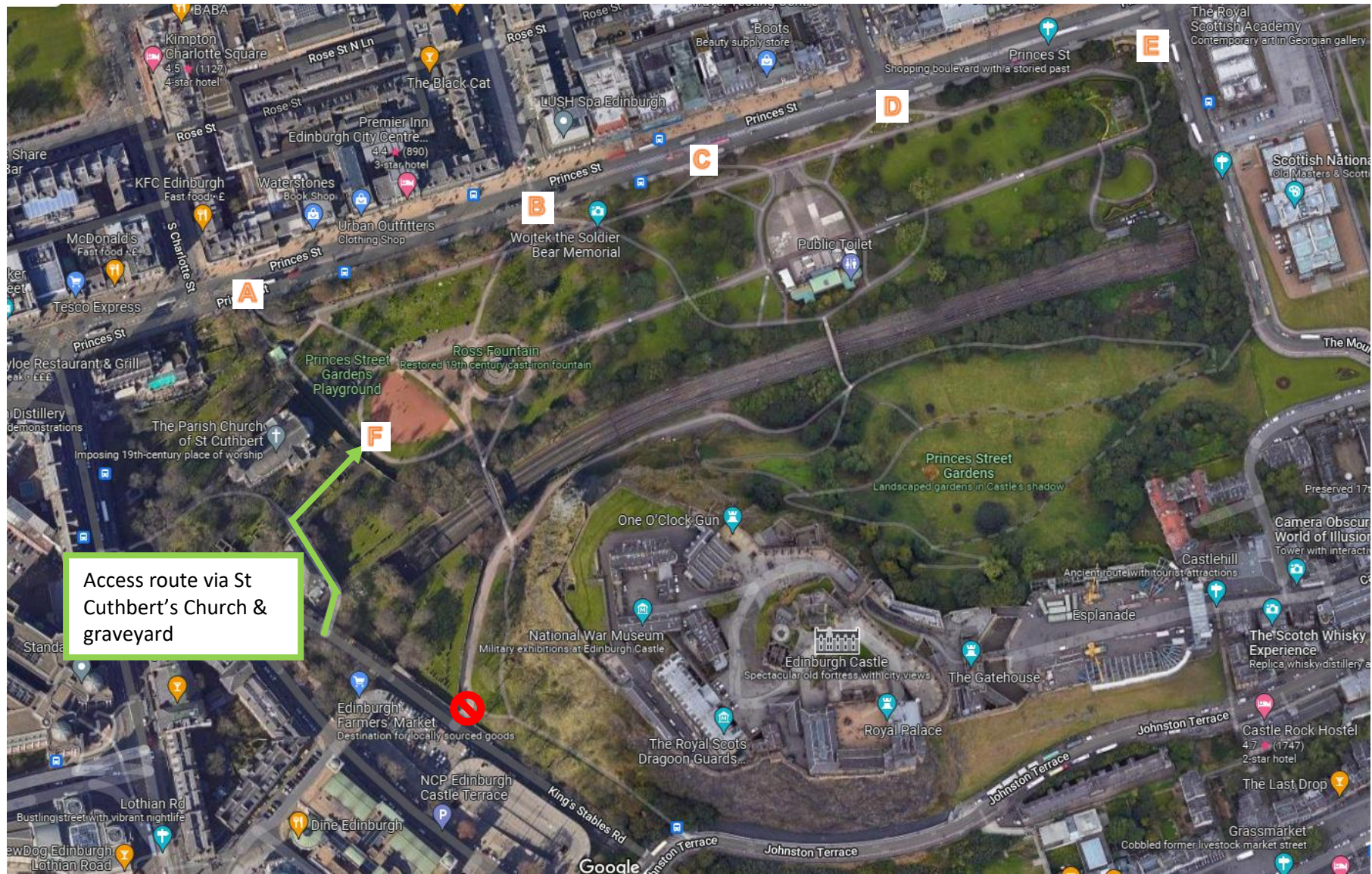
****Gate widths for West Princes Street Gardens**

- A. West End – 3760mm
- B. Castle Street – 2200mm
- C. Frederick/Castle Street – 2280mm
- D. Frederick Street – 2250mm
- E. Floral Clock – 3280mm
- F. St Cuthbert's Churchyard – 3340mm
