### THE CITY OF EDINBURGH COUNCIL (VARIOUS STREETS, CORSTORPHINE) (EXPERIMENTAL TRAFFIC MANAGEMENT MEASURES) (NO 1) EXPERIMENTAL ORDER 2023 - ETRO/21/21

The City of Edinburgh Council in exercise of their powers under sections 9 and 10 of the Road Traffic Regulation Act 1984 as amended (which Act as so amended is hereinafter referred to as "the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:

#### *Citation, commencement and expiry*

1. This Order, which may be cited as "The City of Edinburgh Council (Various Streets, Corstorphine) (Experimental Traffic Management Measures) (No. 1) Experimental Order 2023", shall come into effect on the 24th day of May Two thousand and twenty-three, and shall expire on the 23<sup>rd</sup> day of November 2024.

#### *Interpretation*

2. (1) In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:
  - "article" means an Article of this Order;
  - "bus lane" has the same meaning as in the Transport (Scotland) Act 2001;
  - "Chief Constable" means the Chief Constable of the Police Authority for Police Scotland;
  - "Council" means the City of Edinburgh Council incorporated under the Local Government Etc. (Scotland) Act 1994 as local authority for the City of Edinburgh area;
  - "parking attendant" has the same meaning as in Section 63A of the 1984 Act;
  - "pedal cycle" has the same meaning as in section 151 of the Roads (Scotland) Act 1984;
  - "prohibited hours" means, in relation to any restricted road, the period or periods where said road is subject to a loading/unloading prohibition, as specified in column 5 of Schedule 2, or a prohibition of motor vehicles, as specified in column 4 of Schedule 1;
  - "restricted hours" means, in relation to any restricted road, where said road is subject to a waiting restriction at any time as specified in Schedule 3 and the period or periods specified in column 4 of Schedule 2, in relation to the length of road specified in column 1 of those Schedules;
  - "restricted road" means any road identified in the Schedules as having restricted hours or prohibited hours applying to that road;

"road" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and, for the avoidance of doubt, for the purposes of this Order, includes part of a road;

"Schedule" means a Schedule to this Order;

"taxi" has the meaning assigned to that phrase by Section 23 of the Civic Government (Scotland) Act 1982;

"telecommunication apparatus" has the same meaning as that assigned to that phrase by Section 4 of and Schedule 2 of the Telecommunications Act 1984;

"traffic sign" means a sign of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under, Section 64 of the 1984 Act;

"traffic warden" means an officer employed by the police authority as a traffic warden in pursuance of Section 9 of the Police (Scotland) Act 1967.

"universal service provider" has the same meaning as that assigned to that phrase by Sections 4(3) and 4(4) of the Postal Services Act 2000.

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (3) The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under the 1984 Act or by or under any other enactment.

#### *Prohibition of motor vehicles*

3. (1) Save as provided in Article 4 and Article 5 of this Order, no person shall cause or permit any motor vehicle to enter into or proceed in a length of road specified in Schedule 1 to this Order during the hours specified in column (4).

#### *Restrictions on waiting and loading or unloading*

- (2) Save as provided in Article 4 of this Order, except with the permission of a Parking Attendant, no person shall cause or permit any vehicle to wait or load onto or unload from any vehicle, at any time specified in columns (4) and (5), on any length of road described in Schedule 2 to this Order.

#### *Restrictions on waiting*

- (3) Save as provided in Article 4 of this Order, except with the permission of a Parking Attendant, no person shall cause or permit any vehicle to wait, at any time, on any length of road described in Schedule 3 to this Order.

#### *One-way roads*

- (4) Save as provided in Article 4 and Article 5 of this Order, no person shall cause or permit any vehicle to proceed in a length of road specified in column (1) of the table in Schedule 4 in a direction other than that specified in column (2) of that table.

### *Bus lanes*

- (5) no person shall cause or permit any vehicle to be in, or to enter or proceed in a bus lane described in Schedule 5 between the dates specified in column (3) and hours in column (4) in that Schedule provided that nothing in this Article shall apply to any vehicle being in, entering or proceeding in a bus lane where the person in control of the vehicle:
- a) is required by law to do so; or
  - b) is obliged to be in, or to enter or proceed in a bus lane in order to avoid an accident, or a parked vehicle; or
  - c) is prevented by circumstances out-with their control from avoiding being in, or entering or proceeding other than in the bus lane, and as soon as possible causes the vehicle to leave the bus lane.

### *Exceptions and exemptions from restrictions*

#### 4. Nothing in:

- a) Article 3, paragraphs (1) to (5) shall apply in relation to:
  - (i) anything done with the permission or at the direction of a police constable in uniform or a traffic warden;
  - (ii) any person who causes a vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to section 66 or 67 of the 1984 Act.
  - (iii)
    - a) a vehicle being used, in an emergency, for fire brigade, ambulance or police purposes if it is reasonably necessary for that vehicle to be in, or to enter or proceed in any road described in Schedule 1 or in a bus lane described in Schedule 5, or to wait in any road described in Schedules 2 or 3 to this Order;
    - b) a vehicle being used in connection with the removal of any obstruction in any road described in this Order;
    - c) enable a vehicle in actual use or materially necessary for such purposes, provided that the said vehicle cannot conveniently be used for the same purpose either in any other road not described in this Order, to be used in or adjacent to that road in connection with any:
      - i. building operation; or
      - ii. demolition; or
      - iii. laying, erection, alteration or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any electronic communications apparatus; or
      - iv. excavation,provided that, in the case of any of the operations described in subparagraphs (iii) and (iv) above, the said operation or operations are to be conducted within the extents of that road.
  - d) enable a vehicle in actual use or materially necessary for such purposes, provided that the said vehicle cannot conveniently be used

for the same purpose either in any other road, to be used in connection with any:

- (i) cleansing or lighting of any road; or
- (ii) removal of any obstruction to traffic on any road; or
- (iii) maintenance or improvement or reconstruction of any; or
- (iv) placing, maintenance or removal of any traffic sign or parking meter on any.

provided that in the circumstances described that it is reasonably necessary for the vehicle to be in, to wait in, or to enter or proceed in said road or, as the case may be, in a bus lane.

- e) a vehicle, not being a passenger vehicle, while being used in the service of a local authority in pursuance of statutory powers and duties; provided that in all the circumstances it is reasonably necessary in the exercise of such powers and duties for the vehicle to be in, to wait in, or to enter or proceed in said road or, as the case may be, the bus lane;

- f) a vehicle in the service of a universal service provider;

- b) Article 3 (1) (4) and (5) of this Order shall apply to pedal cycles or pedestrians.
- c) Article 3 (5) of this Order shall apply to a taxi.

5. The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018 is hereby suspended in so far as it is affected by the measures described in Articles 3 (2) and (3) of this Order.

#### *Revocation or amendment of orders*

6. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Edinburgh Corporation (Kirk loan and Manse Road) (One Way) Order, 1962 shall have effect subject to the addition thereto specified in Schedule 6 to this Order;
7. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of Edinburgh Council (Schools Streets, Edinburgh) (Prohibition of Motor Vehicles) Traffic Regulation Order 2017 shall have effect subject to the amendments specified in Schedule 7 of this Order;
8. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of Edinburgh Council (Greenways) Order 1997 shall have effect subject to the amendments specified in Schedule 8 to this Order.


#### *Power to modify or suspend this Order*

9. In pursuance of Section 10(2) of the 1984 Act, the City of Edinburgh Council's Executive Director of Place or an officer of the Council to whom power has been duly delegated, may, if it appears to them or that person essential in the interests of the expeditious, convenient and safe movement of traffic, or for preserving or improving the amenities of the area through which any road affected by this Order runs, after consultation with the Chief Constable, modify or suspend this Order or any provision thereof.
