### THE CITY OF EDINBURGH COUNCIL (DUDDINGSTON PARK SOUTH & THE JEWEL AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/199

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Duddingston Park South & The Jewel Area) (Temporary Road Restriction and Traffic Regulation) Order 2024”. The order shall have effect on the Thirteenth day of January Two thousand and twenty-five and shall remain in force up to and including the Twenty-fifth day of April Two thousand and twenty-five.
2. In this Order the following phrases have the meanings respectively assigned to them:  
“Article” means an Article of this Order;  
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;  
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;  
“the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and  
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate carriageway resurfacing and drainage improvement works (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle ***between 19:00 hours and 06:00 hours of the following day DAILY*** on: (i) **Magdalene Drive**, between its junction with Duddingston Park South and its junction with Bailie Path; (ii) **Mountcastle Drive South**, between its junction with Duddingston Park South and its junction with Durham Road South; (iii) **The Jewel**, from its junction with the roundabout at Duddingston Park South, eastwards to its junction with Redman Drive; (iv) **North Greens**, at its junction with The Jewel; (v) **Parrotshot**, at its junction with The Jewel; (vi) **Hosie Rigg**, at its junction with The Jewel; (vii) **Vexhim Park**, at its junction with The Jewel; (viii) **Corbiewynd**, at its junction with The Jewel; and (ix) **Corbieshot**, at its junction with The Jewel;
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on ***both sides*** of: (i) **Duddingston Park South**, from its junction with Magdalene Drive, southwards to a point 50 metres or thereby south of the roundabout at its junction with The Jewel; (ii) **Magdalene Drive**, between its junction with Duddingston Park South and its junction with Bailie Path; (iii) **Mountcastle Drive South**, between its junction with Duddingston Park South and its junction with Durham Road South; and (iv) **The Jewel** (*both carriageways*), from its junction with the roundabout at Duddingston Park South, eastwards to its junction with Corbieshot.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.

6. "The City of Edinburgh Council (Various Roads, Edinburgh) (Bus Priority Measures) Traffic Regulation Order 2013" will be suspended for the duration of the works in relation to the *bus lanes* on **The Jewel**, between its junction with Corbieshot and its junction with Redman Drive, to allow two-way access.
7. The alternative routes for through vehicular traffic will be by way of: (i) **Magdalene Drive** – Bailie Grove, Bailie Terrace and Duddingston Park South; (ii) **Mountcastle Drive South** – Durham Road South, Milton Road West and Duddingston Park South; and (iii) **The Jewel** – Duddingston Park South, Newcraighall Road, A1, Milton Link and Duddingston Crescent.
8. The following roads have no available diversions, where local access will be maintained: (iv) **North Greens**; (v) **Parrotshot**; (vi) **Hosie Rigg**; (vii) **Vexhim Park**; (viii) **Corbiewynd**; and (ix) **Corbieshot**.
