Introduction

Your December 2024 payslip will reflect an uplift in your salary and other payments for December, and it'll also include back-pay for the eight months between April and November 2024.

As we implemented the new HR and Payroll system in October 2024, your back-pay has been calculated in the old myHR system (for payments made between April and September 2024) and in the new myHR system (for payments made in October and November 2024).

The following guidance explains how this will look on your December 2024 payslip.

Back-pay due – October and November 2024

Back-pay calculated for basic pay and other pay elements for the period between October and November is shown as '**Retroactive**' entries on your payslip.

Back-pay due - April to September 2024

All back-pay calculated for basic pay and other pay elements for the period between April and September 2024, including adjustments, is recorded on your payslip under a single entry **'Misc Adjust 299'**.
