### THE CITY OF EDINBURGH COUNCIL (SRU SIX NATIONS TESTS @ MURRAYFIELD) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/14

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 62 of the Roads (Scotland) Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (SRU Six Nations Tests @ Murrayfield) (Temporary Road Restriction and Traffic Regulation) Order 2025”. The order shall have effect during the hours and on the dates specified in the Schedules to this Order.
2. In this Order the following phrases have the meanings respectively assigned to them:
  - “Article” means an Article of this Order;
  - “authorised vehicle” means any vehicle authorised by City of Edinburgh Council as being connected with the event;
  - “emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;
  - “Parking Attendant” has the same meaning as in Section 63A of the Road Traffic Regulation Act 1984;
  - “public service vehicle” has the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981, and, for the purposes of this Order, applies where the said vehicle or vehicles are being operated as a Local Service, as defined in the said Act;
  - “motor vehicle” has the same meaning as in Section 136 of the Road Traffic Regulation Act 1984;
  - “road” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and, for the avoidance of doubt, for the purposes of this Order, includes part of a road;
  - “Schedule” means a Schedule to this Order;
  - “service bus” means a public service vehicle used for the provision of a local service not being an excursion or tour, and for the purposes of this Order, includes event specific service buses;
  - “the 2025 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025;
  - “tram” shall have the meaning assigned to that phrase by Section 82 of the Edinburgh Tram (Line One) Act 2006; and
  - “vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate the safe ingress and egress of spectators from Murrayfield (as signed as affected by the event/s), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on the roads specified in Schedule 1 hereto, where prohibitions will apply to roads in their entirety unless otherwise stated;
  - (b) walk or cause or permit any person to walk on the footways described in Schedule 2 hereto;
  - (c) drive or cause or permit to be driven any motor vehicle on the sections of roads specified in column 1 of Schedule 3, otherwise than in the direction specified in column 2 of Schedule 3 hereto;
  - (d) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the roads described in Schedule 4 hereto, where

prohibitions will apply to both sides of the roads in their entirety unless otherwise stated;  
and

- (e) drive or cause or permit to be driven any vehicle on the road described in column 1 of Schedule 5 so as to make the prohibited turn specified in column 2 of Schedule 5, into the road specified in column 3 of Schedule 5 hereto.

4. Nothing in:

- (i) Article 3(a) of this Order shall apply to *authorised vehicles* on the affected sections of: **Riversdale Crescent, Riversdale Road, Riversdale Grove, Saughtonhall Circus, Saughtonhall Terrace, Saughtonhall Grove, Saughtonhall Place, Saughtonhall Gardens, Saughtonhall Avenue, Saughtonhall Crescent, Baird Grove, Baird Terrace, Baird Gardens, Baird Avenue, Baird Drive, Western Place, Western Gardens, Wester Coates Terrace, Balbirnie Place, Wester Coates Road, Stanhope Street, Devon Place, Roseburn Avenue, Roseburn Place, Roseburn Drive, Roseburn Crescent, Roseburn Gardens, Russell Gardens, Belmont Gardens, Belmont View, Belmont Park, Belmont Avenue, Belmont Crescent; and Belmont Terrace** specified in Schedule 1 hereto;
- (ii) Article 3(a) of this Order shall apply to *service buses* on the affected section of **Western Terrace/Corstorphine Road** specified in Schedule 1 hereto;
- (iii) Article 3(a) of this Order shall apply to *event specific service buses* on the affected sections of: (i) **West Approach Road**; and (ii) **Westfield Road** specified in Schedule 1 hereto;
- (iv) Articles 3(a) and (c) of this Order shall apply to *trams* on the affected sections of: (i) **Haymarket Terrace**; (ii) **Clifton Terrace**; (iii) **Haymarket Yards**; and (iv) **West Maitland Street** specified in Schedules 1 and 3 hereto; and
- (v) Article 3 of this Order shall apply to emergency service vehicles.


5. Whilst this Order continues in force, ‘The City of Edinburgh Council (Greenways) Order 1997’, ‘The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025’ and ‘The City of Edinburgh Council (Devon Place) (Temporary Road Restriction and Traffic Regulation) Order 2023’ will be suspended during the hours and on the dates specified in the Schedules on any of the affected sections of roads described, to facilitate the event.

6. The alternative routes for through vehicular traffic will be by way of Ellersly Road, Murrayfield Road, Ravelston Dykes and then Belford Road, Douglas Gardens and Palmerston Place; or Queensferry Terrace, Queensferry Road and Queensferry Street; and Westfield Road, Gorgie Road, Dalry Road, Henderson Terrace and Dundee Street. Pedestrian access will be maintained on all roads, except in Article 3(b).

(A) *from 11:15 hours to 18:15 hours on 01/02/2025; from 12:00 hours to 19:00 hours on 09/02/2025; and from 13:45 hours to 20:45 hours on 08/03/2025 on:*

(i) **Riversdale Crescent**; (ii) **Riversdale Road**; (iii) **Riversdale Grove**; (iv) **Saughtonhall Circus**; (v) **Saughtonhall Terrace**; (vi) **Saughtonhall Grove**; (vii) **Saughtonhall Place**; (viii) **Saughtonhall Gardens**; (ix) **Saughtonhall Avenue**; (x) **Saughtonhall Crescent**; (xi) **Baird Grove**; (xii) **Baird Terrace**; (xiii) **Baird Gardens**; (xiv) **Baird Avenue**; (xv) **Baird Drive**; (xvi) **Western Place**; (xvii) **Western Gardens**; (xviii) **Wester Coates Terrace**; (xix) **Balbirnie Place**; (xx) **Wester Coates Road**; (xxi) **Stanhope Street**; (xxii) **Devon Place**; (xxiii) **Roseburn Avenue**; (xxiv) **Roseburn Place**; (xxv) **Roseburn Drive**; (xxvi) **Roseburn Crescent**; (xxvii) **Roseburn Gardens**; (xxviii) **Russell Gardens**; (xxix) **Riversdale Bridge**; (xxx) **Belmont Gardens**; (xxxii) **Belmont View**; (xxxiii) **Belmont Park**; (xxxiv) **Belmont Avenue**; (xxxv) **Belmont Crescent**; and (xxxvi) **Belmont Terrace**.

(B) *from 12:15 hours to 14:15 hours and then from 15:15 hours to 18:15 hours on 01/02/2025; from 13:00 hours to 15:00 hours and then from 16:00 hours to 19:00 hours on 09/02/2025; and from 14:45 hours to 16:45 hours and then from 17:45 hours to 20:45 hours on 08/03/2025 on:*

(i) **Roseburn Street**; and (ii) **Russell Road**, from its junction with Roseburn Street, south-eastwards for a distance of 60 metres or thereby;

(C) *from 12:45 hours to 13:45 hours and then from 15:15 hours to 18:15 hours on 01/02/2025; from 13:30 hours to 14:30 hours and then from 16:00 hours to 19:00 hours on 09/02/2025; and from 15:15 hours to 16:15 hours and then from 17:45 hours to 20:45 hours on 08/03/2025 on:*

(i) **Roseburn Terrace**; (ii) **West Coates**; (iii) **Haymarket Terrace**; (iv) **Clifton Terrace**; (v) **Haymarket Yards**; (vi) **Western Terrace/Corstorphine Road**, between its junction with Ellersly Road and its junction with Roseburn Terrace; (vii) **Rosebery Crescent**, between its junction with Haymarket Terrace and its junction with Grosvenor Gardens; (viii) **Balbirnie Place**; and (ix) **Grosvenor Street**, at its junction with West Maitland Street/Haymarket; and

(D) *from 15:15 hours to 18:15 hours on 01/02/2025; from 16:00 hours to 19:00 hours on 09/02/2025; and from 17:45 hours to 20:45 hours on 08/03/2025 on:*

(i) **West Approach Road**, from the point it joins Westfield Road to the slip road at Dundee Street/Angle Park Terrace; and (ii) **Westfield Road**, from a point 95 metres or thereby north-east of the extended north-eastern kerbline of Westfield Avenue, north-eastwards to the point it joins West Approach Road.

SCHEDULE 2  
PROHIBITION OF PEDESTRIANS

*From 15:15 hours to 18:15 hours on 01/02/2025; from 16:00 hours to 19:00 hours on 09/02/2025; and from 17:45 hours to 20:45 hours on 08/03/2025 on:*

**Balbirnie Place**: (i) from the projected south-west gable end of No. 50 Balbirnie Place, south-eastwards for a distance of 20 metres or thereby; and (ii) *the north-eastern footway*, from the projected south-west gable end of No. 50 Balbirnie Place, north-westwards for a distance of 30 metres or thereby.

SCHEDULE 4  
PROHIBITION OF WAITING, LOADING AND UNLOADING

*From 08:45 hours to 18:15 hours on 01/02/2025; from 09:30 hours to 19:00 hours on 09/02/2025; and from 11:15 hours to 20:45 hours on 08/03/2025 on:*

(i) **Corstorphine Road**: (a) *north side*, between its junction with Roseburn Terrace and its junction with St. John's Road; and (b) *south side*: (1) between its junction with Roseburn Terrace and its junction with Riversdale Crescent; (2) between its junction with Western Corner/Saughtonhall Drive and its junction with St. John's Road; and (3) from its junction with Riversdale Crescent, westwards for a distance of 100 metres or thereby; (ii) **Balgreen Road**: (a) *north-east side*: (1) from its junction with Corstorphine Road, south-eastwards to the projected boundary between Nos. 85 and 87 Balgreen Road; and (2) from the projected south property boundary of No. 87 Balgreen Road, south-eastwards to its junction with Gorgie Road; and (b) *south-west side*: (1) between its junction with Gorgie Road and its junction with Glendevon Road; and (2) between its junction with Balgreen Avenue and its junction with Corstorphine Road; (iii) **Gorgie Road**: (a) *both sides*, between its junction with Balgreen Road and its junction with Chesser Avenue (*excluding recessed parking bays on the south side*); and (b) *north side*, between its junction with Balgreen Road and its junction with Westfield Road; (iv) **Roseburn Street**, *both sides*: (1) between its junction with Westfield Road and its junction with Roseburn Avenue; and (2) between its junction with Roseburn Terrace and its junction with Roseburn Place; (v) **Saughtonhall Avenue**; (vi) **Russell Road**: (a) *north-east side*, from its junction with Roseburn Street, south-eastwards for a distance of 60 metres or thereby (*to the vehicular entrance to the private parking area*); and (b) *south-west side*, from its junction with Roseburn Street, south-eastwards for a distance of 150 metres or thereby; (vii) **Roseburn Terrace**; (viii) **Murrayfield Road**; (ix) **Riversdale Crescent**: (a) *north-west side*, from its junction with Corstorphine Road, south-westwards for a distance of 120 metres or thereby; and (b) *south-east side*, in its entirety; (x) **Riversdale Road**, *east side*, between its junction with Saughtonhall Avenue and its junction with Riversdale Crescent; (xi) **Westfield Road**, *both sides*, between its junction with Roseburn Street and its junction with Westfield Avenue; (xii) **Ellersly Road**; (xiii) **Saughtonhall Drive**: (1) *west side*, from its junction with Corstorphine Road, southwards for a distance of 45 metres or thereby; and (2) *both sides*, from its junction with Saughtonhall Avenue, northwards and southwards for a distance of 15 metres or thereby respectively; (xiv) **Ravelston Dykes Road**, *both sides*, from its junction with Murrayfield Road, westwards for a distance of 60 metres or thereby; (xv) **Ravelston Dykes**: (a) *north side*, from its junction with Murrayfield Road, eastwards to a point 40 metres or thereby east of its

junction with Garscube Terrace; and (b) *south side*, from a point opposite Craigeith Crescent, eastwards to a point 40 metres or thereby east of its junction with Garscube Terrace (*excluding recessed bays*); (xvi) **Balbirnie Place, both sides**, from a point 30 metres or thereby north-west of the entrance to Roseburn Path, south-eastwards to a point 30 metres or thereby south-east of the entrance to Roseburn Path; (xvii) **West Coates**; (xviii) **Haymarket Terrace**; and (xix) **Clifton Terrace**.
