THE CITY OF EDINBURGH COUNCIL (NORTH BRIDGE, SOUTH BRIDGE & MARKET STREET AREA, EDINBURGH) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) (NO. 1) ORDER 2020 - TEMP 20/27

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984, as amended by the Roads (Scotland) Act 1984, and of all other powers enabling them in that behalf hereby make the following Order to facilitate refurbishment works in relation to North Bridge: -

- 1) This Order may be cited as "The City of Edinburgh Council (North Bridge, South Bridge & Market Street Area, Edinburgh) (Temporary Road Restriction and Traffic Regulation) (No.1) Order 2020" and shall come into operation on the Seventeenth day of February Two thousand and twenty. The City of Edinburgh Council is satisfied that the execution of the works referred to in this Order will take in excess of eighteen months.
- 2) Save as provided in Articles 3 and 4 of this Order in order to facilitate the carrying out of the works in relation to North Bridge refurbishment, the use of the roads specified in Schedule 1 attached hereto shall be prohibited, restricted or regulated from time to time by one or more of the measures specified in Schedule 2 attached hereto, all as signed on street as affected by the works.
- 3) Nothing in Article 2 of this Order shall apply to any vehicle which is there in actual connection with the works.
- 4) The alternative routes for through vehicular traffic shall be by way of adjoining roads, as signed. Access for emergency vehicles will be maintained. Pedestrian traffic and access will be maintained.
- 5) The City of Edinburgh Council (North Bridge & Market Street Area, Edinburgh) (Temporary Road Restriction and Traffic Regulation) (No. 1) Order 2018 is hereby revoked.
- 6) The City of Edinburgh Council (A7, North Bridge to South Clerk Street, Edinburgh) (Bus Priority Measures) Traffic Regulation Order 2004 shall be suspended in relation to the bus lanes and loading bays on North Bridge and South Bridge from its junction with Chambers Street to its junction with Princes Street in so far as it is affected by the restrictions specified in this Order, as signed as affected by the works.
- 7) The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018 will be suspended as per the roads described in Schedule 1 to this Order, as signed and affected by the measures applied in Schedule 2 to this Order.
