THE CITY OF EDINBURGH COUNCIL (NEWHAVEN CRUISELINER VISITS) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/38

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (b) of the Road Traffic Regulation 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Newhaven Cruiseliner Visits) (Temporary Road Restriction and Traffic Regulation) Order 2025". The order shall have effect during the hours and on the dates specified in Schedule 1 of this Order.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;
  - "Schedule" means a Schedule to this Order;
  - "the 2025 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and
  - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4 of this Order, to facilitate cruise liner visits, no person shall, except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the roads specified in Schedule 1 hereto, as signed as affected by the cruise liner visits.
- 4. Nothing in Article 3 of this Order shall apply to emergency service vehicles.
- 5. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3 of this Order.

## SCHEDULE 1 PROHIBITION OF WAITING, LOADING & UNLOADING

(A) from 05:00 hours to 22:00 hours on:

02/04/2025, 10/04/2025, 13/04/2025, 15/04/2025, 22/04/2025 and 30/04/2025;

04/05/2025, 09/05/2025, 10/05/2025, 16/05/2025, 18/05/2025, 20/05/2025, 25/05/2025 and 30/05/2025;

06/06/2025, 11/06/2025, 12/06/2025, 21/06/2025 and 29/06/2025;

02/07/2025, 04/07/2025, 17/07/2025, 18/07/2025, 19/07/2025, 20/07/2025, 23/07/2025, 25/07/2025 and 30/07/2025;

02/08/2025, 06/08/2025, 08/08/2025, 10/08/2025, 14/08/2025, 21/08/2025, 24/08/2025, 26/08/2025, 28/08/2025, 30/08/2025 and 31/08/2025; and

03/09/2025, 04/09/2025, 13/09/2025, 16/09/2025, 21/09/2025, 22/09/2025 and 27/09/2025;

- (B) from 05:00 hours on **07/08/2025** to 02:00 hours on **08/08/2025**;
- (C) from 05:00 hours on 13/08/2025 to 03:00 hours on 14/08/2025; and
- (D) from 05:00 hours on **01/09/2025** to 22:00 hours on **02/09/2025**; and from 05:00 hours on **09/09/2025** to 22:00 hours on **10/09/2025** on:
- (i) **Pier Place**, *north side*, from a point 7 metres or thereby west of the westernmost extent of the harbour slipway, westwards for a distance of 80 metres or thereby; and
- (ii) **Newhaven Place**: (a) *south side*, from the extended western kerbline of the vehicular entrance to the residents' car park (*to the rear of Nos. 110-114 Lindsay Road*), westwards for a distance of 80 metres or thereby; (b) *west side*: (i) from the extended western kerbline of the south vehicular entrance to Fishmarket car park to the extended southern kerbline of the north vehicular entrance to Fishmarket car park; and (ii) from the extended northern kerbline of the north vehicular entrance to Fishmarket car park to the entrance to Nos. 51-53 Newhaven Place car park; and (c) Access to Nos. 13-21 Newhaven Place (*south leg*) *both sides*, from the extended southern kerbline of Newhaven Place (*main carriageway*), southwards for a distance of 20 metres or thereby.
